National health insurance tax commensurate with a term before and after delivery (said tax for 4 months) will be exempted!

## Objectives • Term of notification

- The insured of National health insurance who have had delivery since November, Reiwa 5 year, 2023.

  Pregnancy longer than 85 days (four months) is the objective. (Stillbirth, miscarriage, premature delivery and abortion are included.)
- Notification is possible six months before the estimated date of delivery. It is possible after delivery too.

## National health insurance tax exemption procedure

Health insurance tax commensurate with a term from the previous month of the estimated month of delivery or the
month of delivery until two months after the estimated month of delivery or the month of delivery called "Term
before and after delivery" will be reduced from said tax per income and said tax per capita basis which you are to
pay the fiscal year. (Hereinafter "Term before and after delivery".)

\*\*National health insurance tax per income and that per capita basis commensurate with said tax during a term before and after delivery will be reduced. (The amount of said tax per household will not change.)

XIn the event of multiple pregnancy, National health insurance tax for six months will be reduced three months before the estimated month of delivery (or the month of delivery).

\*\*As for a household which has reached the limit of the amount of tax, the amount of tax will not change.

 Regarding Reiwa 5 year, 2023, only National health insurance tax for January, Reiwa 6 year, 2024 and after will be reduced during a term before and after delivery.
